Article 3: The Department of Finance and Equipment has the mission to develop at the level of the Primature, the elements of the policy in the field of the management of financial and material resources and the supply of services.

As such, it is responsible for:

- to develop the Prime Minister's budget and ensure its execution; - to ensure the execution of public funds made available to the Primature; - proceed with the establishment of the various administrative accounts relating thereto; - ensure the supply of services under the Primature; - proceed with the award of contracts in accordance with the regulations in force; - to ensure the keeping of stock accounts.

CHAPTER II: ORGANIZATION AND OPERATION

Section 1: Management

Article 4: The Department of Finance and Material of the Primature is headed by a Director appointed by decree of the Prime Minister. He has the rank of Central Service Director.

Article 5: The Director of Finance and Equipment is responsible for directing, programming, coordinating and controlling the activities of the service.

Article 6: The Director of Finance and Materials is assisted by a deputy who automatically replaces him in the event of vacancy, absence or incapacity.

The Deputy Director is appointed by decree of the Prime Minister on the proposal of the Director of Finance and Equipment. The decree of appointment also sets the specific attributions of the deputy director.

Article 7: The director benefits from the same advantages as the Technical Advisers of the Primature.

Article 8: The Deputy Director benefits from the same advantages as the Directors of Finance and Equipment of the ministerial departments.

Section 2: Structures

Article 9: The Department of Finance and Equipment comprises three (3) divisions:

- the Expenses division; - the Contracts and Public Procurement division; - the Material Accounting division.

Article 10: The Expenses Division is responsible for:

- preparing and executing expenditure; - to carry out studies on the budgetary strategy; - to prepare reconciliation statements with the treasury and the banks; - drawing up the financial statements; - to communicate extracts from the budget made available to the Prime Minister's Office; - to ensure the monitoring and control of the execution of the Special Investment Budget of the Prime Minister's Office.

Article 11: The Contracts and Public Procurement Division is responsible for:

- drawing up public procurement projects, leases and agreements and participating in monitoring their execution; - to ensure compliance with the rules and procedures for awarding public contracts and contracts for supplies, works or services concerning the budgets or funds placed under the control of the Prime Minister; - maintain and update the file of potential suppliers; - to keep the documents of examination and evaluation of the offers; - to ensure compliance with notification deadlines and formal notice or termination procedures.

Article 12: The Stores Accounting Division is responsible for:

- update all accounting documents and files necessary for the proper management of materials and equipment according to the rules of stock accounting; - to certify invoices, purchase orders and sign the acceptance reports; - to prepare periodic accounting documents; - to propose the disposal of equipment belonging to the Primature; - keep files of accounting documents.

Article 13: The heads of division, except the head of the Stores Accounting division, are appointed by order of the Prime Minister on the proposal of the Director of Finance and Equipment.

The Head of the Stores Accounting Division is the Stores Accountant. He is appointed by order of the Minister in charge of Finance.

As such, he benefits from the same advantages as the heads of the stores accounting division of the ministerial departments.

Article 14: Division heads enjoy the same benefits as division heads of central State services.

Article 15: A special advances authority may be created if necessary with the Prime Minister.

Section 3: Operation

Article 16: Under the authority of the Director of Finance and Equipment, the heads of division prepare technical studies, action programs concerning matters relating to their sector of activity, carry out the periodic evaluation of the programs implemented, implement, coordinate and control the activities of agents placed under their authority.

Article 17: The activity of coordination and control is exercised by:

- a power of prior instruction relating to the content of the decisions to be taken and the activities to be carried out; - a right of intervention a posteriori on the decisions consisting in the exercise of the power of approval, suspension, reformulation or cancellation.

CHAPTER III: FINAL PROVISIONS

Article 18: The details of the organization and the operating methods of the Directorate of Finance and Material of the Primature are fixed by decision of the Director of Cabinet of the Prime Minister.

Article 19: This decree repeals Decree No. 89-298/P-RM of September 30, 1989 establishing the organization and operating procedures of the Administrative and Financial Departments and will be recorded and published in the Official Journal.

Article 4: The Directorate of Human Resources of the Primature is headed by a Director appointed by decree of the Prime Minister.

Article 5: The Director of Human Resources is responsible, under the authority of the Prime Minister, for directing, programming, coordinating and controlling the activities of the service.

Article 6: The Director of Human Resources is assisted by an assistant who replaces him automatically in the event of vacancy, absence or impediment.

The Deputy Director is appointed by decree of the Prime Minister on the proposal of the Director of Human Resources.

The decree of appointment also determines the specific attributions of the deputy director.

Article 7: The director benefits from the same advantages as the Technical Advisers of the Primature.

Article 8: The Deputy Director benefits from the same advantages as the Directors of Human Resources of the sectors.

Section 2: Structures

Article 9: The Human Resources Department includes:

A staff:

- the Documentation and IT unit.

Online: three (3) divisions:

- the Career Management division; - the Remuneration and Information System division; - the Training, Jobs and Skills division.

Article 10: The Documentation and IT Unit is responsible for:

- collect, process and disseminate documentary production relating to human resources; - to keep the computer file of the personnel up to date; - to define the technical characteristics of the IT and communication materials and equipment of the services under the Prime Minister's Office; - monitor the installation and operation of IT and communication materials and equipment.

Article 11: The Career Management Division is responsible for:

- prepare draft administrative and personnel management acts; - to ensure the evaluation of staff; - centralize staff rating sheets; - to monitor career management and propose measures to motivate agents; - to develop and manage social dialogue.

Article 12: The Remuneration and Information System Division is responsible for:

- drawing up and verifying salary statements;

- to harmonize the personnel computer file and the balance file;
- produce statistics on human resources.

Article 13: The Training, Jobs and Skills is loaded:

- developing and implementing the sectoral training and development plan; - ensure the monitoring and evaluation of training; - plan staffing needs; - developing and updating procedures manuals and other human resource management tools; - keep and update individual personnel files.

Article 14: The divisions, the cell are directed respectively by the Heads of division and Cell.

The heads of division and cell are appointed by order of the Prime Minister on the proposal of the Director of Human Resources.

Article 15: Heads of Division and Cell benefit from the same advantages as heads of division of the central services of the State.

Section 3: Operation

Article 16: Under the authority of the Director of Human Resources, the division and cell heads prepare the technical studies, the action programs concerning the matters relating to their sector of activity, carry out the periodic evaluation of the programs implement, coordinate and control the activities of the agents placed under their authority.

Article 17 : The coordination and control activity is carried out by:

- a power of prior instruction relating to the content of the decisions to be taken and the activities to be carried out; - a right of intervention a posteriori on decisions consisting of the exercise of the power of approval, suspension, reformulation or cancellation.

CHAPTER III: FINAL PROVISIONS

Article 18: The details of the organization and the operating methods of the Human Resources Directorate of the Prime Minister are set by decision of the Director of the Prime Minister's Office.

STATUTING IN THE COUNCIL OF MINISTERS,

CHAPTER I: GENERAL PROVISIONS

Article 1: This decree establishes the organization and operating procedures of the General Delegation of Malians Abroad.

Article 2: The General Delegation of Malians Abroad is headed by a General Delegate appointed by decree taken in the Council of Ministers, on the proposal of the Minister responsible for Malians Abroad.

Article 3: The Delegate General of Malians Abroad is responsible, under the authority of the Minister, for leading, coordinating and controlling the activities of the service.

Article 4: The Delegate General of Malians Abroad is seconded and assisted by a Deputy Delegate General who replaces him by right in the event of vacancy, absence or impediment.

The Deputy General Delegate is appointed by order of the Minister responsible for Malians Abroad. The appointment order also sets out its specific responsibilities.

CHAPTER II: ORGANIZATION

Article 5: The General Delegation of Malians Abroad includes:

A staff:

- the Computer and Documentation Center; - the Welcome and Orientation Office.

Online :

- the Department of Administrative and Consular Affairs; - the Department of Economic Promotion and Reintegration of Malians Abroad;

- the Department of Reception and Information for Malians Abroad;

- the Department of Migration Statistics and Prospects.

At local level :

- The Reception, Information and Orientation Antennas for Malians Abroad.

Article 6: The Computing and Documentation Center is responsible for:

- supervise network equipment; - to assist staff in using the IT tool;

- to develop applications that meet the needs of the service;

- manage documentation and archives.

Article 7: The Reception and Orientation Office is responsible for:

- to ensure the reception and orientation of users; - to develop tools within the framework of welcoming, guiding and informing users.

Article 8: The Department of Administrative and Consular Affairs is responsible for:

- to monitor litigation files; - to ensure the administrative management of Malians Abroad in relation with diplomatic and consular missions;

- to assist, protect and secure Malians abroad and their property in relation to diplomatic and consular missions;

- to follow the administrative censuses as well as the civil status certificates of Malian citizens abroad in collaboration with the diplomatic and consular missions;

- to ensure the supply of diplomatic and consular missions, in particular with consular documents, passports and travel documents.

Article 9: The Department of Administrative and Consular Affairs comprises two (2) sections:

- the Consular Administration, Legislation and Regulation ;

- the Social, Cultural and Educational Affairs Section.

Article 10: The Department of Economic Promotion and Reintegration of Malians Abroad is responsible for:

- establish an effective partnership with Malians living abroad;

- to ensure the creation of conditions allowing genuine participation of Malians from abroad in the process of economic and social development of the country;

- dealing with all issues related to the development and monitoring of the savings and investment of Malians living abroad;

- to draw up a directory of Malian economic operators abroad;

- develop and monitor reintegration projects for Malians abroad;

- analyze and monitor investment projects of Malians Abroad;

- to mobilize Malians living abroad for greater investment in the country.

Article 11 : The Department of Economic Promotion and Reintegration of Malians Abroad comprises two (2) sections:

- Economic Promotion and Investment Section, - Reintegration of Returning Malians Section.

Article 12 : The Department of Reception and Information for Malians Abroad is responsible for:

- to welcome Malians from abroad returning forcibly or voluntarily;

- to inform the authorities about the return of Malians from abroad;

- to provide returning Malians living abroad with all useful information;

- to provide elements of initial assistance to Malians Abroad;

- develop reception, orientation and information tools for Malians living abroad;

- to keep records relating to the return of Malians from abroad.

Article 13 : The Department of Reception and Information for Malians Abroad includes:

- Reception and information section, - Administrative formalities section.

Article 14 : The Department of Statistics and Prospectives des Migrations is in charge of:

- to carry out studies and research on international migration issues, particularly those having an impact on Malians Abroad;

- participate in the collection and use of operational statistical data;

- identify and monitor Malian nationals working in international organizations in order to promote their promotion and the admission of new candidates;

- to keep statistics of Malians Abroad Graduates with a view to their future employment.

Article 15 : The Department of Statistics and Migration Prospects includes (03) three sections:

- the Statistics Section; - the Studies and Forecasts Section;

- the Monitoring and Promotion Section of Malian graduates and Malians working in international organizations.

Article 16 : The Reception, Information and Orientation Antennas for Malians Abroad are attached to the General Delegation of Malians Abroad. Their mission is to ensure the reception, information and orientation of Malians abroad.

As such, they are responsible for:

- to welcome returning Malians from abroad;

- to inform the General Delegation of Malians Abroad about the return of Malians Abroad;

- to provide returning Malians living abroad with all useful and urgent information;

- to assist returning Malians from abroad; - keep registers relating to the return of Malians from abroad.

The Reception, Information and Orientation Antennas for Malians Abroad are created by order of the Minister responsible for Malians Abroad.

Article 17 : An order from the Minister for Malians Abroad establishes the organization and operating methods of the Reception, Information and Orientation Antennas for Malians Abroad.

Article 18 : The departments, office, center, sections and branches are directed respectively by heads of department, office, center, section and branch.

The heads of department of Office, center and branch are appointed by order of the Minister in charge of Malians Abroad on the proposal of the General Delegate of Malians Abroad

Section heads are appointed by decision of the Minister responsible for Malians Abroad on the proposal of the General Delegate for Malians Abroad.

Heads of Department, Bureau, Center and Branch have the rank of Head of Division of a central service.

CHAPTER III: OPERATION

SECTION I: PREPARATION OF THE SERVICE POLICY

Article 19 : Under the authority of the Delegate General of Malians Abroad, the Heads of Department, Office, Center and Antenna are responsible for:

- to prepare the technical studies, the programs concerning the matters relating to their sectors of activity; - to carry out the periodic evaluation of the programs implemented; - coordinate and control the activities of the sections.

Article 20 : The section heads have the following tasks:

- to provide, at the request of the heads of Department, the elements of information essential to the development of studies and action programs;
- to proceed with the drafting of directives and service instructions concerning their field of activity.

SECTION II: COORDINATION AND MONITORING THE IMPLEMENTATION OF THIS POLICY

Article 21 : Coordination, control and monitoring of the implementation of the management policy for Malians Abroad are ensured by the General Delegation of Malians Abroad in conjunction with the diplomatic and consular missions.

CHAPTER IV: FINAL PROVISIONS

Article 22 : An order of the Minister in charge of Malians Abroad sets the details of the operating rules and the methods of application of the provisions of this decree.

STATUTING IN THE COUNCIL OF MINISTERS,

DECREES:

CHAPTER I: ORGANIZATION

Article 1 : The Truth, Justice and Reconciliation Commission (CVJR) is placed under the authority of the Minister responsible for National Reconciliation.

Article 2 : The CVJR is made up of twenty-five (25) members who bear the title of "Commissioners" appointed by decree taken by the Council of Ministers on the proposal of the Minister in charge of National Reconciliation.

Article 3 : The CVJR is headed by a President assisted by two Vice-Presidents, all appointed by decree taken in the Council of Ministers on the proposal of the Minister responsible for National Reconciliation.

Article 4 : The bodies of the CVJR are:

- the Plenary Assembly; -
- the Executive Committee;
- the General Secretariat; -
- the Working Sub-Committees; - the regional branches.

Article 5 : The Plenary Assembly is composed of all the members of the Truth, Justice and Reconciliation Commission. It constitutes the orientation and decision-making body of the Commission.

It adopts its internal regulations, the work schedule and the reports of the Commission.

Article 6 : The Executive Committee of the Truth, Justice and Reconciliation Commission is composed of the President, the two (2) Vice-Presidents, the Secretary General and the Commissioners in charge of the Working Sub-Commissions. It executes the decisions of the Plenary Assembly and sees to the proper functioning of the Commission.

Article 7: The President directs and ensures the proper functioning of the Commission. It coordinates with the ministries and administrations concerned.

In case of absence or impediment, he is replaced by the 1st Vice-president; failing this, by the 2nd Vice-President.

Article 8 : The General Secretariat assists the President in the administrative and financial management of the Truth, Justice and Reconciliation Commission.

It is headed by a Secretary General appointed by decree of the Prime Minister on the proposal of the Minister in charge of National Reconciliation.

The composition, organization and functioning of the General Secretariat are determined by order of the Minister responsible for National Reconciliation.

Article 9 : The Truth, Justice and Reconciliation Commission is made up of five (5) Working Sub-Commissions and Regional Branches. The Working Sub-Committees are:

- 1) the Truth-seeking Sub-Commission;
- 2) the Subcommittee responsible for victim support and reparations;
- 3) the Subcommittee responsible for studies, reports and documentation;
- 4) the Subcommittee responsible for awareness-raising and reconciliation;
- 5) Gender Sub-Committee.

Working Sub-Committees may create working cells within them.

Article 10: A Consultative Committee of fifteen (15) members is created at each regional branch responsible for supporting the CVJR in carrying out its various missions.

Article 11 : The composition, organization and operating methods of the working sub-committees, regional branches and the Consultative Committee are established by order of the Minister of National Reconciliation, upon proposal from the President of the Truth, Justice and Reconciliation Commission. .

CHAPTER II: MODALITIES OF FUNCTIONING

Article 12 : The Truth, Justice and Reconciliation Commission meets when convened by its President.

Article 13 : Meetings of the Truth, Justice and Reconciliation Commission are held at its headquarters in Bamako or at any other place in the national territory if necessary.

Article 14: The Truth, Justice and Reconciliation Commission establishes its Rules of Procedure and its program of activities and submits them for approval to the Minister of National Reconciliation of Mali.

Article 15: The Truth, Justice and Reconciliation Commission may carry out any investigation, in particular hear any expert and have any document communicated to it in accordance with the texts in force.

Article 16 : The Truth, Justice and Reconciliation Commission draws up periodic progress reports which are transmitted to the Minister in charge of National Reconciliation of Mali.

At the end of the work, it produces a final report containing recommendations. This final report is submitted by the President of the Truth, Justice and Reconciliation Commission to the President of the Republic, the Prime Minister, the Minister of National Reconciliation and the President of the National Assembly.

CHAPTER III: FINAL PROVISIONS

Article 17 : A decree issued by the Council of Ministers fixes the advantages granted to the members of the Truth, Justice and Reconciliation Commission and to those of the General Secretariat.

The advantages and emoluments granted to the members of the Consultative Committee are fixed by joint decree of the minister responsible for national reconciliation and the minister responsible for finance.

Article 18 : This decree repeals Decree No. 2014-0013/P-RM of January 15, 2015 establishing the organization and operating procedures of the Truth, Justice and Reconciliation Commission.

Article 19 - The Minister of National Reconciliation of Mali, the Minister of Economy and Finance and the Minister of Justice and Human Rights, Keeper of the Seals are responsible, each as far as they are concerned, for the execution of the this decree which will be registered and published in the Official Journal.

DECREE N° 2015-0887/P-RM DU DECEMBER 31 2015 CREATING THE ORDER OF SPORTS MERIT

THE PRESIDENT OF THE REPUBLIC

Considering the Constitution;

Having regard to Law No. 63-311 AN/RM of May 31, 1963 on creation of National Orders in the Republic of Mali;
In view of Decree No. 194/IPG of September 17, 1963 on public administration regulations for the application of Article 12 of Law No. 63-31/AN-RM of May 31, 1963 establishing National Orders in the Republic of

They had;

Having regard to Decree No. 98-215 of July 2, 1998 governing the physical and sports activities;
Considering the Decree n°2015-0003/P-RM of January 08, 2015, appointing the Prime Minister;
Having regard to Decree No. 2015-0603/P-RM of September 24, 2015, appointing members of the Government;

ACTING IN COUNCIL OF MINISTERS

DECREES:

CHAPTER I: GENERAL PROVISIONS

Article 1 : There is hereby created in the Republic of Mali a honorary distinction called "Order of Merit Sporty".

Article 2: The Order of Sporting Merit is intended for reward athletes, sports leaders, as well as

people who have contributed to the development of sport, physical and sporting activities in Mali, or who have provided exceptional services to national and international sporting bodies.

Article 3 : The insignia of the Sports Merit Order consists of a decoration and a ribbon.

Article 4 : The insignia of the Order of Sports Merit is a medal 35 mm in diameter presenting on its back the monogram "RM" in metal with around the three sports circles in the Malian colors, on its reverse the central inscription " Order of Sports Merit" with an eagle surrounded by the inscription: " **REPUBLIC OF MALI – ONE PEOPLE – ONE GOAL – ONE FAITH**".

The Medal is suspended from a moiré ribbon with a total width of 32 mm, green in color bearing two stars in its center and bordered on each side by two yellow and red stripes, 3 mm each.

CHAPTER II: ADMINISTRATION OF THE ORDER SPORTING MERIT

Article 5: The President of the Republic is the Grand Master of the Order of Sports Merit.

Article 6: The Grand Chancellor of National Orders is responsible for the administration of the Order of Sports Merit.

He is assisted by the Council of the Order of Sports Merit.

Article 7: The Grand Chancellery of the National Orders of Mali, in conjunction with the Ministry responsible for Sports, ensures the permanence of the activities of the Council of the Order of Sports Merit.

To this end, the Ministry in charge of Sports prepares reports and draft budgets relating to the Order of Sports Merit.

Article 8: The Council of the Order of Sports Merit is composed as follows:

- the Grand Chancellor of National Orders...President;
- the National Director of Sports and Physical Education.....Member;
- the National Director of Youth.....Member;
- the representative of the Minister of National Education.....Member;
- the Director of Sport for the Armed Forces.....Member;
- the President of the National Olympic and Sports Committee of Mali.....Member.

Article 9: The members of the Council of the Order of Sports Merit are appointed by decree taken by the Council of Ministers, on the proposal of the Grand Chancellor of National Orders and the Minister in charge of Sports.

Article 10: The Council of the Order of Sports Merit ensures compliance with the texts governing the Order.

He gives his opinion on:

- the draft budget established by the Ministry responsible for Sports,
- all questions relating to the Order of Sports Merit.

CHAPTER III: CONDITIONS OF ADMISSION, FOR ADVANCEMENT AND DELETING

Article 11: To be admitted to the Order of Sports Merit, one must enjoy one's civic rights and demonstrate exceptional results in the practice of physical and sports activities, in the sports movement, in sports competitions, in the administration of the sports, in the fields of partnership and the sports industry.

Article 12: The appointment to the rank of the Order of Sports Merit takes place each year, on the occasion of the national holiday of September 22 during the commemorative ceremonies of the Independence of Mali.

The Sports Merit Order may be awarded on an exceptional basis by the President of the Republic.

The Sports Merit Order is awarded during ceremonies, presided over by a member of the Government, assisted by the staff of the Grand Chancellery of National Orders.

However, in the Regions, the Governors of the Regions may award the said decorations.

Article 13: The member of the Government or the Governor of the Region proceeds with the ceremonial, hereafter, to the reception of the persons named in the Order of Sports Merit.

It sends the recipient the following formula:

"Sir..... (Grade and quality)
.....".

"In the name of the President of the Republic and by virtue of the powers conferred on us, we award you the Order of Sporting Merit".

Article 14: The Order of Sports Merit is awarded by decree of the President of the Republic, on the proposal of the Minister in charge of Sports, after consulting the Council of the Order of Sports Merit.

Article 15: The conditions for deregistration are as follows:

- non-respect of the national flag,
- refusal to honor or represent the national colors.

Article 16: The striking off of the Sports Merit Order takes place by decree of the President of the Republic, taken in the Council of Ministers.

CHAPTER IV: FINAL PROVISIONS

Article 17: An order of the Minister in charge of Sports fixes the details and the methods of application of this decree.

Article 18: The Minister of Sports and the Minister of Economy and Finance, are each responsible for the execution of this decree, which will be registered and published in the Official Journal.

2015 SETTING THE TERMS AND CONDITIONS FOR IMPLEMENTING
THE SAFETY CHARGE FOR
THE OPERATION OF AN INTEGRATED SYSTEM OF
IMMIGRATION CONTROL ON
MALI AIRPORTS**

THE PRESIDENT OF THE REPUBLIC,

Considering the Constitution;

Considering Law No. 61-118/AN-RM of August 18, 1961 approving the accession of the Republic of Mali to the Convention relating to International Civil Aviation, signed in Chicago on December 7, 1944;

Given Decree No. 2015-003/P-RM of January 8, 2015 appointing the Prime Minister;

Having regard to Decree No. 2015-0603/P-RM of September 24, 2015 appointing members of the Government,

STATUTING IN THE COUNCIL OF MINISTERS,

DECREES:

Article 1 : It is instituted as of January 1 , 2016, a fee called "security fee".

Article 2: The security fee exclusively finances the investment relating to the establishment and operation of an integrated immigration control system at the international airports of Mali.

Article 3: The security charge is payable by any passenger of any public air transport company using commercial flights to and from Mali.

Article 4: The security fee is included in the price of the ticket. It is settled and collected by the air transport company or, where applicable, by the airport manager on commercial flights. It is based on the number of passengers embarked and disembarked at Mali's international airfields, regardless of the tariff conditions granted by the carrier.

Article 5: The Concessionaire Company, guarantor of the improvement and maintenance of investments for the safety of passengers arriving and departing from airports in Mali, is authorized to collect the security fee.

It will be able to use the invoicing data of the air transport company.

Article 6: The rate of the security fee as well as the share of each structure involved in the accomplishment of the missions are fixed by mutual agreement with the concessionary company.

Article 7: Payment of the security fee is made monthly and no later than the 15th of the month following the invoicing period.

Article 8: The security fee is paid each month according to the share which goes to each structure concerned in the accomplishment of the missions.

Article 9: Any delay in payment of the security fee is punishable by a penalty, the rate of which is fixed in agreement with the concession company.

Article 10: The Minister of Security and Civil Protection, the Minister of Equipment, Transport and Opening up and the Minister of Economy and Finance are responsible, each in his respective capacity, for the execution of this decree.

Article 11: This decree will be published in the Official Journal.
