*Article 6, paragraph 1 and 2 of the Federal Law of Rights

To determine the quota of the rights established in this Law, fractions of weight will be considered; Notwithstanding the foregoing, to make your payment, the amount will be adjusted so that those containing amounts that include 1 to 50 cents are adjusted to the immediately preceding peso unit and those that contain amounts from 51 to 99 cents are adjusted to the next higher unit of weight.

When in the same act the taxpayer must make the payment of two or more rights, he must consider, in any case, the fee without adjustment that corresponds to each right, and only the sum of them will be applied to the adjustment referred to. the previous paragraph.
