Proceed with payment of the consideration fee and submit evidence of payment. Fee payment and submission Documents requested for

consideration must be complete, then the documents will be taken into the next consideration process. 3.

Payment of fees for for joint research institutes It is the responsibility of the researcher and the research funder in accordance with the institutional announcements. Including preparing documents for submission to the joint research institute, It's a responsibility, of researchers and research

funders, with the number of documents depending on the according to the requirements of that institution

4. In the case where the researcher has transferred the fee before The research project documents have not yet been submitted. After canceling and requesting a refund, the Foundation will deduct 20% of the transferred fee. As for the service fee from the bank, the researcher will be responsible.
