Study and experiment on humans, such as new drugs, tools/technology and medical products, etc. The researcher must request to submit the research project and various information to the Ethics Committee.

Human research of the organization under consideration But currently there is joint clinical research at many institutions. This causes duplication in consideration of various institutions that are considering human health research in Thailand. Therefore made an agreement to establish "Office of the Central Research Ethics Committee on Human Research" or Central Research Ethics Committee (CREC) is a central agency for considering multi-institutional research projects. The Human Research Ethics Committee of hospitals and agencies under the Ministry of Public Health also joins CREC.



However, ethical considerations for research involving human subjects It is a delicate and complex work. and requires close and continuous coordination with various sectors.
